4. First-aid measures

First-aid measures

- Inhalation** : Keep person warm and at rest. If unconscious, place in recovery position and get medical attention immediately. The exposed person may need to be kept under medical surveillance for 48 hours.
- Ingestion** : Wash out mouth with water. Keep person warm and at rest. If unconscious, place in recovery position and get medical attention immediately.
- Skin contact** : Flush contaminated skin with plenty of water. Remove contaminated clothing and shoes. Obtain medical attention if symptoms occur. Wash clothing before reuse. Clean shoes thoroughly before reuse.
- Eye contact** : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.

5. Fire-fighting measures

6. Accidental release measures
